



### **iFoil Emerging Nations Support**

The list is comprised of all nations currently classed as World Sailing Emerging Nations

Nations have been categorised into 4 groups:

- Those who need financial assistance and have an existing windsurfing program
- Those who need financial assistance but don't have an existing windsurfing program
- Those who are financially stable and have an existing windsurfing program
- Those who are financially stable but don't have an existing windsurfing program

The final group is those who are currently suspended MNA's. They can be categorised if the suspension is lifted.

If iFoil would like to query a nation or a nation makes an application to them to receive different support, this can be reviewed with World Sailing.

Nations who receive boards with financial support from IFoil will commit to the following development goals:

- Host an annual National Championships involving all the purchased iFoil boards. This can be run as its own championships or included in other championships but each year a national champion should be awarded
- Have at least one sailor representing the nation at the regional championships each year.
- Take part in annual Class World Championships
- Compete in Olympic Qualification events.
- Send World Sailing an annual report on Development of the class in their country.

If a nation fails to meet these criteria, they will no longer be eligible for the iFoil Emerging Nations support.
